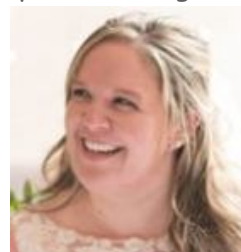


**Bible Teacher – Marjorie Black**

Allie's passion is showing children that they are loved by the King and empowering them to impact the Kingdom.

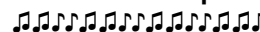
